

**General Rules & Regulations**

- Each junior exhibitor must be a bona fide member, in good standing, of an Oklahoma 4-H and/or FFA Chapter. Also, eligible to show are 5-7-year-old youth too young to enroll in a 4-H club, who were enrolled in a Caddo County School System as of January 1, of the current year.
- Unsportsmanlike conduct or inappropriate behavior, as identified by fair superintendents or fair officials, by an exhibitor or associated parties, at any time during the Caddo County Spring Livestock Show, on any location on the fairgrounds, are grounds for suspension from further exhibition and for dismissal from the fairgrounds. The Caddo County Free Fair Board reserves to its management the final and absolute right to interpret all rules and regulations in this exhibitor handbook, and arbitrarily settle and determine all matters, questions, and differences in regard there to or otherwise arising out of, connected with, or incident to the Fair. The Management reserves the right to amend or add to these rules as they, in their judgment, may deem advisable.
- Exhibitors must show their own project. If the exhibitor has more than one animal in any class or is physically disabled\* at the time of the show, he or she may have another eligible exhibitor for their local 4-H and/or FFA Chapter to show the animal or animals.
- Bedding will be furnished by the exhibitor (wood chips only.)
- Entries will be released after the selection of the Grand Champion Market Animal of their species.
- No animal infected with any disease will be permitted to occupy any of the exhibit pens, but the board will not be held responsible for any outbreak of disease that may occur through a violation of this rule.
- Final entries are due by 11:59 PM, Saturday, February 17<sup>th</sup>, 2024. All entries will be done through a google docs form online at <https://forms.office.com/r/aT6rtXSX4A>
- All exhibits, grounds, and buildings shall be under the control of the Caddo County Fair Board, but neither officers nor the board will in any case be responsible for any injury, loss or damage that may occur to any person, livestock, or property.
- All animals must be owned by and cared for by the exhibitor following the ownership rules of the Oklahoma Youth Expo for their specific species. Those rules can be found at [www.okyouthexpo.com](http://www.okyouthexpo.com).
- All show animals must have a 'Premise I.D.
- Protests: The time period for filing a protest for all species will end at the selection of the Grand

Champion of that species. Protests must be in writing and must include a \$300 cash protest fee, refundable if the protest is upheld. The protest must be signed by the complainant and state who is involved, what the violation is, when the violation occurred, and where the violation occurred. Protest forms and decisions will be filed with the CCFFB Secretary for record keeping purposes.

- Showmanship Classes will be divided into Junior Division 3<sup>rd</sup> – 6<sup>th</sup> Grade, Intermediate Division 7<sup>th</sup> – 9<sup>th</sup> Grade, and Senior Division 10<sup>th</sup> – 12 Grade. 4-H members must be both 8 years old and in the 3<sup>rd</sup> Grade. Exhibitors must show their own animal in the showmanship class.
- LIVESTOCK EXHIBITOR DRESS CODE:
  - Ages 5-7 will wear a white collared shirt, jeans, and close-toed shoes while in the show ring. All 4-H & FFA exhibitors will be required to wear appropriate dress to represent their organization. The following is approved:
    - 4-H Members: An official 4-H vest, jacket, or pullover wind jacket. Must be of the appropriate colors of solid green, solid white, or a mix of green and white. Must have an official 4-H emblem of at least 2½ inches that is permanently affixed to the front and left side of the vest or jacket. Must wear a button-up, collared shirt under the vest or jacket that is of the appropriate colors of solid green, solid white, or a mix of green and white.
    - 4-H Members: A button up, collared shirt or polo shirt, short or long sleeve, of the appropriate 4-H colors of solid green, solid white, or a mix of green and white. No third color mix, or additional colors are allowed. Must have an official 4-H emblem of at least 2½ inches that is permanently affixed to the front and left side of the shirt.
    - FFA Members: An official FFA corduroy jacket or a pullover wind jacket. A pullover wind jacket must be of the appropriate colors of solid blue, solid yellow, or a mix of blue and yellow. Must have an official FFA emblem of at least 2½ inches that is permanently affixed to the front and left side of the pullover wind jacket. Must wear a button-up, collared shirt under either jacket that is of the appropriate colors of solid white, solid blue, solid yellow, or a mix of blue and yellow.
    - FFA Members: A button up, collared shirt or polo shirt, short or long sleeve, of the appropriate FFA colors of solid white, solid blue, solid yellow, or a mix of blue and yellow. No third color mix, or additional colors are allowed. Must have an official FFA emblem of at least 2½ inches that is permanently affixed to the front and left side of the shirt.
    - 4-H & FFA Members: No headgear is allowed.

- 4-H & FFA Members: The Show Ring Dress Code is also required and will be enforced during media appearances.
- Any exhibitor who wants to assist as a Jr. Superintendent needs to notify a Caddo County Fair Board Member prior to the show.
  - Youth who have been declared ineligible to participate in extra-curricular activities by their local school administration will be declared ineligible to participate in this Caddo County Spring Livestock Show.
  - Anyone barred from any other show holding membership with the International Association of Fairs and Expositions will not be allowed to participate in the Caddo County Spring Stock Show.
- \* Instances of physical disability and alternate exhibitor eligibility are at the discretion of the division superintendents

**SUPERINTENDENTS: Casey Hilmes & Alison Whitney**  
**BREEDING SHOW ORDER: Southdown, Shropshire, Dorset, Dorper, Hampshire, Suffolk, Natural Color Market Lambs, and Commercial Ewe Lamb**

- Ewes cannot show as a Market Lamb.
- All sheep must be slick shorn to be exhibited.
- Yearling ewes must have lost one (1) or more baby teeth but not have over two (2) permanent teeth visible.
- An exhibitor may show three (3) head of market lambs and three (3) head of ewes.
- All ewe lambs and yearling ewes in the Breeding Sheep Show must be registered and recorded by a recognized breed association in the name of the exhibitor.
- Scrapie tags must be in ewe's ears when entries are due.
- There will be a commercial ewe lamb class for unregistered ewe lambs in the Breeding Sheep Show. Commercial ewes will be divided into classes by weight.
- All sheep exhibitors will abide by the general rules and regulations of the Caddo County Spring Livestock Show.

**SUPERINTENDENTS: Scott Rose, Jess Matlock**  
**SHOW ORDER: Heifers, Prospect Steers, Market Steers**

- An exhibitor may show two (2) heifers, two (2) prospects steers, and two (2) market steers.
- All heifers in the Heifer Show must be registered and recorded by a recognized breed association in the name of the exhibitor. Each registered heifer must have the correct percentage of genetics to meet eligible show requirements for that specific breed, except for the Commercial Heifer Class. No 'Pending Registrations' will be accepted.
- The Commercial Class will be eligible for the Grand Champion drive.
- Tattoos must be in heifer's ears and must correspond with the registration papers. I
- Registration papers must show the animal was owned by the exhibitor prior to January 15, 2023. Except Prospect Steers which must be owned 2 weeks prior to the show.
- No "force-filling".
- Superintendents will divide steers and heifers into competitive classes based on breed and weight. Exhibitors will weigh their own animals. Bred & Owned Heifer Class will need required registration papers for proof of breed and ownership. Commercial heifers cannot show in the Bred & Owned Class. Prospect steers must weigh under 951 lbs., but the superintendents reserve the right to ensure the most equitable and competitive classes.
- All cattle exhibitors will abide by the general rules and regulations of the Caddo County Spring Livestock Show.

**Swine Division**

**SUPERINTENDENT: Wade Miller, & Jason Ramming**  
**SHOW ORDER: Berkshire, Chester White, Duroc, Hampshire, Hereford, Landrace, Poland China, Spots, Yorkshire, Crossbred. Gilts followed by barrows.**

- Exhibitors will declare weight on entry form.
- No "force-filling" of any swine.

3. Water only will be used for dressing.
4. All pigs must be ear notched to show in the pure-bred classes.
5. All pigs must be Pseudorabies and Brucellosis tested with proper proof as required by ODAFF regulations or originate from a Validated & Qualified (VQ) Herd. If originating from a VQ Herd, the VQ Herd number, most recent quarterly test date, and animal identification shall be listed on a valid Certificate of Veterinary Inspection (CVI) or other document signed by an accredited veterinarian. This paperwork will be checked at the show. A photocopy of the pseudo papers/CVI will be turned into the swine superintendent and animals verified. Please bring a photocopy to leave with the superintendent. A 'Premise I.D.' is required for all swine. All swine entries must be identified with an 840 (EID/RFID) tag.
6. The weight limit for barrows will be 280 lbs. Weight limit for commercial gilts will be 340 lbs. Pure-bred gilts are shown by age.
7. One (1) exhibitor may show three (3) gilts and/or three (3) barrows.
8. Feeding pens may be used if they are setup outside, or inside if space is available. No pens may be torn down for feeding pens. No feeding in the show holding pens, arena, or show barn walkways. No swine will be penned in the sheep barn.
9. All swine exhibitors will abide by the general rules and regulations of the Caddo County Spring Livestock Show.
10. To show in the purebred classes, all purebred gilts must have registration papers. Purebred gilts must have birthdates between July 1, 2023, and October 31, 2023. Registration papers must be transferred into the name of the exhibitor by the respective breed association. Registration papers that are signed on the back by the respective breeder but not officially transferred into the exhibitor's name by the breed association will not be accepted. Registration papers will be checked when the exhibitor turns in their entry card. All exhibitors must have original registration papers, registration papers can be originals, faxed copies, or an email with attached registration papers from the breed associations. All purebred gilts will be entered by age. All gilts not having/showing registration papers will be shown in the commercial gilt classes and will be entered by weight.
11. Superintendents will determine swine breeds.

**Goat Division**

**SUPERINTENDENTS: Casey Hilmes & Alison Whitney**

1. All goats must be meat goats.
2. There will be a limit of three (3) breeding goats and (3) market goats per exhibitor.
3. All breeding goats must have scrapie tag or be in a certified herd. Registration papers will not be required.
4. Entries will be assigned a Class by weight. Meat Goat Classes will be divided into Divisions by the Superintendents.
5. No bracing of doe goats, exhibitors bracing doe goats will be dismissed by the show superintendents and/or judge.
6. No billies will be allowed to show in any division.
7. All meat goats must resemble a Boer or be a member of a meat goat breed. All wethers will show as market goats. There must be more than 3 goats to be broken into 2 or more classes.
8. All goat exhibitors must abide by the general rules and regulations of the Caddo County Junior Livestock Show.

1. Exhibitors must have owned and personally cared for their poultry at least 50 days prior to the day to the show.
2. Exhibitors are not limited in the number of entries.
3. All poultry entries must be of recognized breeds. Birds of a breed not listed below will show in the Other Breeds Class.
4. All poultry exhibited shall be free of visible evidence of disease.
5. Exhibitors will be required to furnish their own coops, feeders, and water containers.
6. All entries will be required to take a blood test or be a participant in the National Poultry Improvement Plan with official documentation. A state certified poultry tester will

7. be present to take blood samples. The Caddo County Free Fair will pay the testing fees.
7. All breeds are determined by superintendents.
8. Entries are due by 11:59 PM, Saturday, February 17<sup>th</sup>, 2023. All entries will be done through a google docs form online at <https://forms.office.com/r/aT6rtXSX4A>
