At any time after nomination date the Ottawa County Fair Board has the right to inspect ALL livestock entries to determine if all exhibitors entries are at the specified location that was given at nomination time, ANY livestock that will be off premises of the above location for longer the four (4) days will be required to notify the Ottawa County Extension Office 918-542-1688 and state the reason for animals being at a different location. Any exhibitors that change primary location of animals from one location to another permanent location must notify the Ottawa County Extension Office, ANY animal found by the Ottawa County Fair Board that is not at the specified location and has not met the required criteria as to animal being at another location will be:

(First offense) Deemed ineligible to compete at the Ottawa County Fair as well as all other animals entered by the same exhibitor or family.

(Second offense) The exhibitor and/or family will be banned from showing at the Ottawa County Fair entirely in future years.
