## **OSU Extension Offers**

## **Master Gardening Short Course**

Have you ever wondered what that weed in your yard is or how to take better care of the plants in your house? Do you want to expand your knowledge of vegetable gardening or caring for the trees in your yard? Oklahoma Extension has an educational program for you! Starting in January through February, we will be offering a Master Gardening Short Course for anyone who wants to learn about lawns, trees, shrubs, flowers, and gardens.

The Oklahoma Extension Master Gardening Short Course will be held on Tuesdays starting January 23<sup>rd</sup> and go for six weeks ending February 27, 2024. The classes will be held from 10:00am to 3:00pm. To be named a Master Gardening Graduate you must attend 12 classes. So, this course is offered once a year receiving half the credit this year and the other half of the classes in 2025.

This year we will be offering 6 classes in Cotton and Stephens Counties. On January 23rd, we will kick off this year's education learning about Plant Pathology at the Cotton County Fairgrounds in Walters. On January 30, we will be covering Botany and Plant Physiology at the Stephens County Fairgrounds in Duncan. Turfgrass will be our topic on February 6th at the Cotton County Fairgrounds in Walters with the leading turf specialist in the state Dr. Dennis Martin. On February 13th, we will be back in Duncan at the Stephens County Fairgrounds to learn about Raised Beds and Organic Gardening with our favorite Horticulture Educator, Julia Laughlin. February 20th, we will cover Pesticide Use and Safety at the Cotton County Fairgrounds in Walters. February 27th will conclude our classes with the topic about Landscape Design at the Stephens County Fairgrounds in Duncan.

The course is open to area residents with a high school diploma, who are interested in learning the latest Oklahoma State University research-based home horticulture information and practices. The registration fee is \$60/1<sup>st</sup> year participants and \$30 for continuing participants and is nonrefundable. All past Master Gardeners Graduates are welcome, and classes are \$10 for the set. There will be a virtual option for individuals who request that service. Registration Fees cover weekly lecture from experts in the field, master gardener manual comprised of OSU Fact sheets ranging from topics on soils to Oklahoma Proven plants, fertilizers, and pesticides, and much more. **Pecan Crop Course** - Enrollment for the 2024 Oklahoma Pecan Management Course is now open! Enroll early! Last year, the class filled up in a couple of weeks. February 27 will be the first meeting. Other dates are April 2, May 7, July 2, August 6, September 10, & October 15. The class meets one Tuesday afternoon each month from 1-5pm at the Cimarron Valley Research Station near Perkins. We will not meet in June but encourage participants to attend the Oklahoma Pecan Growers Associational meeting. This year it will be held in Ardmore on May 30-June 1. The fee to sign-up is \$250 per person. The course is limited to 35 participants and the deadline for enrollment is February 16.
