

# **Show Ring Code of Ethics**

Believing it is in the best interest of all breeders of all livestock to maintain a reputation of integrity and to continue to present a wholesome and progressive image in the show ring, the following list of practices or procedures is, therefore, considered a violation of the Rules and Regulations governing this show.

- 1. Misrepresenting the age of the animal or the grade of the exhibitor for the class in which it is shown.
- 2. Treating or massaging any part of the body internally or externally with an irritant, counter-irritant, or other substance to temporarily straighten a weak back or loin or produce unnatural animation.
- 3. Minimize the effects of campiness by feeding or injecting drugs, depressants, or applying packs or using any artificial contrivance or therapeutic treatment exempting normal exercise.
- 4. Striking the animal to cause swelling.
- 5. Surgery or any other procedure performed to change the natural process of growth, maturation, contour or appearance of any animal to include teeth is prohibited. Not included is the removal of teats or horns, clipping and dressing of hair and trimming of hooves.
- 6. Insertion of foreign material under the skin.
- 7. Any attempt to change the natural color of an animal, either purebred or crossbred, by changing the color or adding false hair, fleece, or skin at any point, spot, or area of the animal's body.
- 8. The use of alcoholic beverages in feed or administered as a drench.
- 9. Administration of a drug of any kind or prescription, internally or externally, prior to entering the show ring, except for treating a recognized disease or injury. For the purpose of these rules, the term legal drug shall mean any substance by which the sale, possession, or use of is controlled by license under federal, state, or local laws or regulations and by any substance commonly used in the medical or veterinary professions. The use of any chemical and/or compound that is not approved by the Food and Drug Administration or the Environmental Protection Agency. A positive drug test will result in disqualification, forfeiture of any premiums and/or awards and will also exclude the exhibitors from future livestock competition at the Tulsa County Fall Fair. All medications will be administered by a licensed veterinarian only and with the species superintendent's approval.
- 10. The practice of artificial filling by internally pumping or any other device is prohibited.
- 11. Criticizing or interfering with the judge, other exhibitors, breed representatives or show officials before, during or after the event may result in an individual or group being expelled, placed on probation, declared ineligible, or barred from exhibiting at the event.

Any violation of the Rules and Regulations specifically designed for the individual shows or the Show Ring Code of Ethics may result in forfeiture of all premiums and awards and the disqualification, expulsion or probation of the exhibitor, organized group, or any individual, or livestock involved. Probation, disqualification, expulsion or other disciplinary action of the Management will be final. Such action will require an application for readmission under such terms as the Management may prescribe before the group or individual is allowed to exhibit in future events.

## **General Rules and Regulations**

- 1. All exhibitors must be a member of a certified Tulsa County 4-H Club or FFA Chapter 60 days prior to the show.
- 2. Show Ring Dress Code (based on Tulsa State Fair and OYE guidelines) Exhibitors will wear one of the following:

#### 4-H Member:

An official 4-H vest, jacket, sweater or pullover wind jacket.

- Must be appropriate colors of solid green, solid white, or a mix of green and white. No black or grey will be accepted.
- Must wear a collared shirt under the vest or jacket that is appropriate colors of solid white, solid green, or a mix of green and white.
- Must have official 4-H emblem of at least 2 ½ inches that is permanently affixed to the front, left side of the vest or jacket. **No club or farm logo will be accepted.**

A buttoned up, collared shirt or polo shirt, short or long sleeve, of the appropriate 4-H colors of solid green, solid white, or a mix of green and white.

 Must have an official 4-H emblem of at least 2½ inches that is permanently affixed to the front, left side of the shirt. No club or farm logo will be accepted.

No third color mix or additional colors will be accepted for any of the previously listed clothing options. (E.g. no black, grey, tan, or any other)

No club or farm logo shall appear on any article of clothing.

#### FFA Member:

A buttoned up, collared shirt or polo shirt, short or long sleeve, of the appropriate FFA colors of solid white, solid blue, solid yellow, or a mix of blue and yellow.

- No third color mix or additional colors are allowed.
- Must have an official FFA emblem of at least 2½ inches that is permanently affixed to the front and left side of the shirt.

#### FFA members may wear their FFA jacket for the Tulsa County Fall Fair.

- 3. Exhibits must have been owned and fed daily by the Tulsa County 4-H or FFA member for a minimum of 60 days.
- 4. Exhibitors are limited to 3 entries per show. (example 3 market entries, and 3 breeding entries)
- 5. Should the health of an animal be questioned, a visual inspection will be made by the species superintendent or a veterinarian. Any animal not passing will be removed from the premises.
- 6. All swine must have the original negative pseudo-rabies and Brucellosis test results form with ear tag in place as required by State Department of Agriculture. Premise ID will be required. Either the original paper or original digital results form will be accepted.
- 7. Except for an emergency, exhibitors will be required to show their own animal. Examples of emergencies are: illness, significant personal or family accidents, etc. In the event of an emergency, permission must be obtained from the species superintendent and Extension personnel to allow another Tulsa County 4-H or Tulsa County FFA member to show for them. In the event the same exhibitor has two or more animals that are required to show at the same time, the owner-exhibitor can have a bona fide Tulsa County 4-H or Tulsa County FFA member to show the second or more animals for them without seeking committee approval.
- 8. All animals requiring weigh-in must be weighed-in during designated weigh-in times on official scales provided by the show staff. Failure to weigh-in during designating time will result in the animals' disqualification.
- 9. Registration papers on breeding animals must be in the name of the exhibitor and be presented to the superintendent at the time of entry. Official, paper copies are required. No pictures on electronic devices or digital copies will be accepted.
- 10. In order to show in the species' Bred and Owned show, exhibitors must bring an official, paper copy showing that the exhibited animal is registered and that they owned the dam when she was bred. Bred and owned market animals may also show in the Bred and Owned show but must be registered and meet the same requirements as the B/O breeding animals.

- 11. Market animals may be purebred or crossbred. If necessary, a committee will determine breed classification.
- 12. The stalling of sheep, goats, or pigs on the trailer will be extremely limited and will be available on a first come, first served basis. Parking in fire lanes, in front of overhead doors and walk-through doors, and blocking other trailers/vehicles in will not be tolerated and may result in the towing of the trailer/vehicle at the owner's expense.
- 13. Exhibitors must furnish feed and bedding. No straw is allowed for bedding.
- 14. The Tulsa County Junior Livestock Show Committee shall have the authority to settle questions which may arise concerning the show. Only the show committee is allowed in the show ring and scale area during check-in.
- 15. Decisions of the Show Committee, species superintendents, and judges are final. There will be no protest.
- 16. All exhibitors must show their own animals in the showmanship contest.
- 17. Animals shown in the showmanship contest must be officially entered in the 2025 Tulsa County Fall Fair.
- 18. NEW THIS FALL Female animals (i.e. does, ewes, and gilts) must show in their species' breeding show and will no longer be able to choose to participate in the market show (only male animals).
- 19. Failure to abide by the General Rules and Regulations, Show Ring Code of Ethics shall cause forfeiture of all premiums or awards and further participation in the Tulsa County Fall Fair.
- 20. In no case shall the Tulsa County Junior Livestock Show Committee, Owasso FFA Chapter, or Owasso FFA Alumni be responsible for any loss, damage, or disability.
- 21. This is a youth and family event. Responsible conduct is expected and required at all times. Profanity or any other offensive language, abusive conduct or act by an exhibitor, Extension Educator, AgEd Teacher, or exhibitor family member will be considered a violation of the Show Ring Code of Ethics and will be subject to the penalties outlined in this fair book. Abusive conduct is defined as, but not limited to, aggressively touching, verbally or physically threatening show officials and/or throwing objects in the presence of show officials.

All animals must be checked in during designated check-in time. Failure to check-in during designated time will result in the animals' disqualification. All registered females must have a legible tattoo matching registration papers to be eligible to show. This will be enforced. If not in compliance, females will not be shown or will be shown as a commercial female.

#### **Heifer Rules**

- 1. Heifers must be owned and fed by the exhibitor for 60 days.
- 2. Tattoos must be in the ear of all registered heifers and may be checked by Beef superintendent or his/her representative at check-in. If no tattoo is present, the animal will be shown as commercial.
- 3. Heifers must be born between September 1, 2023 and May 1, 2025 to be eligible to show. Registration papers for registered heifers will be examined during check-in and must be recorded and registered solely in the name of the individual exhibitor by August 1, 2025.
- 4. Classes will be broken by superintendent.
- 5. Breeds with an individual breed show at the Tulsa State Fair will be allowed to show within their specific breed. Purebred and percentage registered animals (i.e. Shorthorn and Shorthorn Plus) will be shown together. All other breeds not individually recognized by Tulsa State Fair will be allowed to show in

either the AOB or Commercial division. Two (2) animals of a breed and two or more owners from two or more households are required to constitute a breed; otherwise, they will be shown as AOB (DOB) or Commercial (weight).

- 6. AOB (if needed) will be the first breed to show in the registered heifer show. AOB class will show regardless of number.
- 7. Commercial heifer classes will be broken by weight.
- 8. Heifers can be shown as Registered or Commercial Heifers but **NOT** both.
- 9. There is no weight limit and no papers required for commercial heifers.
- 10. In order to show in the Bred and Owned class, the heifer must be registered in the exhibitor's name, and papers must show exhibitor owned the dam when she was bred.
- 11. All heifers must be free of contagious disease. Heifers determined to be infected with a contagious disease, will not be allowed to show and must be removed from the barn.
- 12. Heifers must possess all their baby teeth with no signs of permanent teeth.
- 13. Fitting will not be allowed. This includes adhesives and paint.

#### **Steer Rules**

- 1. All steers must be owned and fed by the exhibitor for 60 days.
- 2. Classes will be broken by weight. Steers weighing 1099 pounds and under will show as a Prospect Steer. Steers weighing 1100 pounds and over will show as a Market Steer. There is no weight limit.
- 3. Class size will be determined by the Beef Division Superintendent.
- 4. In order to show in the Bred and Owned class, the steer must be registered in the exhibitor's name, and papers must show exhibitor owned the dam when she was bred.
- 5. All steers must be free of contagious disease. Heifers determined to be infected with a contagious disease, will not be allowed to show and must be removed from the barn.
- 6. Steers must possess all their baby teeth with no signs of permanent teeth.
- 7. Fitting will not be allowed. This includes adhesives and paint.

## **Beef Showmanship**

- 1. All exhibitors must show their own animals in the showmanship contest.
- 2. Animals shown in showmanship contest must be officially entered in the 2025 Tulsa County Fall Fair.

## **Breeding Gilt Rules**

- 1. Breeding gilts must be owned and fed by the exhibitor for 60 days.
- Registered gilts will be shown by age and registration papers will be examined during check-in. Commercial gilts will be shown by weight. There is no weight limit. All gilts must be ear notched and healed.
- 3. All registration papers must be recorded in the name of the exhibitor.
- 4. All gilts must show in the Breeding Gilt division. Gilts can no longer elect to show in the Market Barrow show.
- 5. Purebred gilts will be shown by age. Purebred Gilts must be farrowed between January 1, 2025 and April 30, 2025. **No papered barrows; all barrows must show in market swine show.**
- 6. Two (2) animals of a breed and two or more owners from two or more households are required to constitute a breed; **otherwise**, **they will be shown as AOB (DOB) or Commercial (weight)**. AOB class will show regardless of number.
- 7. The Swine Division Superintendent will be responsible for determining class size, swine weigh-in and classification.
- 8. All swine must have the original negative pseudo-rabies and Brucellosis test results form with ear tag in place as required by State Department of Agriculture. Premise ID will be required. Either the original paper or original digital results form will be accepted.

- 9. In order to show in the Bred and Owned class, the gilt must be registered in the exhibitor's name, and papers must show exhibitor owned the dam when she was bred.
- 10. AOB (if needed) will be the first breed to show in the breeding gilt show.
- 11. All gilts must be free of contagious disease. Gilts determined to be infected with a contagious disease, will not be allowed to show and must be removed from the barn.
- 12. Fitting will not be allowed. This includes adhesives and paints.

#### **Market Barrow Rules**

- 1. Market swine must be owned and fed by the exhibitor for 60 days.
- 2. All barrows must show in this division and will be shown by weight.
- 3. Market barrows must weigh during designated check in time to determine official weight. There is no weight limit.
- 4. Two (2) animals of a breed and two or more owners from two or more households are required to constitute a breed; **otherwise**, **they will be shown in the crossbred class**.
- 5. The Swine Superintendent will be responsible for determining class size and classification.
- 6. All swine must have the original negative pseudo-rabies and Brucellosis test results form with ear tag in place as required by State Department of Agriculture. Premise ID will be required. Either the original paper or original digital results form will be accepted.
- 7. In order to show in the Bred and Owned class, the market barrows must be registered in the exhibitor's name, and papers must show exhibitor owned the dam when she was bred.
- 8. All market barrows will show by breed in alphabetical order with crossbreds last.
- 9. All market barrows must be free of contagious disease. Swine determined to be infected with a contagious disease, will not be allowed to show and must be removed from the barn.
- 10. Fitting will not be allowed. This includes adhesives and paints.

#### **Breeding Ewe Rules**

- 1. Ewes must be owned and fed by the exhibitor for 60 days.
- 2. Registered ewes will be shown by age and will be verified during check-in (via registration papers). Commercial ewes will be shown by weight.
- 3. All ewes must show in the Breeding Ewe division. Ewes can no longer elect to show in the Market Lamb show.
- 4. Must have two or more animals of a breed, owned by two or more exhibitors from two or more households to constitute a breed. Otherwise, they will be shown as AOB (DOB) or Commercial (weight).
- 5. Classes will be broken by superintendent.
- 6. In order to show in the Bred and Owned class, the breeding ewe must be registered in the exhibitor's name, and papers must show exhibitor owned the dam when she was bred.
- 7. Ewe lambs must have all 8 temporary incisors with no visible signs of permanent incisors. Yearling ewes must have 6 temporary incisors and 1 pair of permanent incisors.
- 8. All breeding ewes must be free of contagious disease. Ewes determined to be infected with a contagious disease, will not be allowed to show and must be removed from the barn.
- 9. Fitting will not be allowed. This includes adhesives and paints.

#### **Market Lamb Rules**

- 1. Market lambs must be owned and fed by the exhibitor for 60 days.
- 2. Market lambs will show by breed. Classification will be done at check-in.

  Superintendent has final decision regarding a sheep's breed classification.
- 3. No minimum or maximum weight.
- 4. Classes will be broken by superintendent.
- 5. Two (2) animals of a breed and two or more owners from two or more households are required to constitute a breed; **otherwise**, **they will be shown in the crossbred class**.
- 6. Market lambs will be shown slick shorn.
- 7. In order to show in the Bred and Owned class, market lambs must be registered in the exhibitor's name, and papers must show exhibitor owned the dam when she was bred.
- 8. All market lambs must be free of contagious disease. Lambs determined to be infected with a contagious disease, will not be allowed to show and must be removed from the barn.
- 9. There will not be a Market Suffolk breed this year (to align with Tulsa State Fair breed changes)
- 10. Fitting will not be allowed. This includes adhesives and paints.

#### **Breeding Doe Rules**

- 1. All breeding does must be owned and fed by the exhibitor for 60 days.
- 2. All breeding does will be shown by weight.
- 3. All does must show in the Breeding Doe division. Does can no longer elect to show in the Market Goat show.
- 4. No bucks are allowed to show.
- 5. No weight limits.
- Class size will be determined by the Meat Goat Division Superintendent.
- 7. In order to show in the Bred and Owned class, the breeding doe must be registered in the exhibitor's name, and papers must show exhibitor owned the dam when she was bred.
- 8. **Breeding does cannot be braced. No exceptions.** The judge and species superintendent have the authority to ask the exhibitor to step back from the animal.
- 9. Breeding goats must have milk teeth.
- 10. All breeding does must be free of contagious disease. Does determined to be infected with a contagious disease, will not be allowed to show and must be removed from the barn.
- 11. Fitting will not be allowed. This includes adhesives and paints.

#### **Market Goat Rules**

- 1. All market goats must be owned and fed by the exhibitor for 60 days.
- 2. All market goats will be shown by weight.
- 3. No bucks are allowed to show.
- 4. No weight limits.
- 5. Market goats will be shown slick shorn.
- 6. Class size will be determined by the Meat Goat Division Superintendent.
- 7. In order to show in the Bred and Owned class, the market goat must be registered in the exhibitor's name, and papers must show exhibitor owned the dam when she was bred.
- 8. Bracing is allowed in the Market Goat show only.
- 9. Market goats must have milk teeth.
- 10. All market goats must be free of contagious disease. Goats determined to be infected with a contagious disease, will not be allowed to show and must be removed from the barn.
- 11. Fitting will not be allowed. This includes adhesives and paints.

## **Meat Goat Showmanship**

- 1. All exhibitors must show their own animals in the showmanship contest.
- 2. Animals shown in showmanship contest must be officially entered in the 2025 Tulsa County Fall Fair.
