

Show Ring Code of Ethics

Believing it is in the best interest of all breeders of all livestock to maintain a reputation of integrity and to continue to present a wholesome and progressive image in the show ring, the following list of practices or procedures is, therefore, considered a violation of the Rules and Regulations governing this show.

1. Misrepresenting the age of the animal or grade of the exhibitor for the class in which it is shown.
2. Treating or massaging any part of the body internally or externally with an irritant, counter irritant or other substance to temporarily straighten a weak back or loin or to produce unnatural animation.
3. Minimize the effects of crampiness by feeding or injecting drugs, depressants or applying packs or using any artificial contrivance or therapeutic treatment exempting normal exercise.
4. Striking the animal to cause swelling.
5. Surgery or any other procedure performed to change the natural process of growth, maturation, contour or appearance of any animal to include teeth is prohibited. Not included is removal of teats or horns, clipping and dressing of hair and trimming of hooves.
6. Insertion of foreign material under the skin.
7. Any attempt to change the natural color of an animal, either purebred or crossbred, by changing the color or adding false hair, fleece or skin at any point, spot or area of the animal's body.
8. The use of alcoholic beverages in feed or administered as a drench.
9. Administration of a drug of any kind or description, internally or externally, prior to entering the show ring, except for treating a recognized disease or injury. For the purpose of these rules, the term legal drug shall mean any substance by which the sale, possession or use of is controlled by license under federal, state or local laws or regulations and by any substance commonly used in the medical or veterinary professions. The use of any chemical and/or compound that is not approved by the Food and Drug Administration or the Environmental Protection Agency. A positive drug test will result in disqualification, forfeiture of any premiums and/or awards and will exclude the exhibitors from future livestock competition at the Tulsa County Spring Livestock Show. All medications will be administered by a licensed veterinarian only and with the species superintendent's approval.
10. The practice of artificial filling by internally pumping or any other device is prohibited.
11. **Criticizing or interfering with the judge, other exhibitors, breed representatives or show officials before, during or after the event may result in an individual or group being expelled, placed on probation, declared ineligible or barred from exhibiting at the event.**


Any violation of the Rules and Regulations specifically designed for the individual shows or the Show Ring Code of Ethics may result in forfeiture of all premiums and awards and the disqualification, expulsion or probation of the exhibitor, organized group, or any individual, or livestock involved. Probation, disqualification, expulsion or other disciplinary action of the Management will be final. Such action will require application for readmission under such terms as the Management may prescribe before the group or individual is allowed to exhibit in future events.



Behavioral Guidelines for Extension Educators and Volunteers Working with 4-H Youth Development Programs

Oklahoma families and other youth service programs trust in the Oklahoma Cooperative Extension Service to provide educational programs in a safe environment for participating youth. Adults who assume Educator and volunteer roles within Extension have the opportunity for a rewarding experience. The opportunity to work with youth is a privileged position of trust that should be held only by those who are willing to demonstrate behaviors that fulfill the trust. The following behavioral expectations have been established for persons serving in Educator and volunteer roles within Oklahoma Cooperative Extension Service programs.

1. Work cooperatively with youth, family, volunteers, Oklahoma Cooperative Extension Service faculty and staff, and others in a courteous, respectful manner demonstrating behaviors appropriate for a positive role model for youth.
2. Represent the Cooperative Extension Service and the 4-H program with pride and dignity, behave appropriately, exhibit good sportsmanship, and demonstrate reasonable conflict management skills.
3. Respect, adhere to, and enforce the rules, policies and guidelines established by the Oklahoma Cooperative Extension Service including all state laws related to child abuse and substance abuse.
4. Recognize that verbal or physical abuse or committing criminal acts are grounds for termination as a volunteer or 4-H Youth Development Educator.
5. Comply with equal opportunity and anti-discrimination laws. Make all reasonable efforts to assure that 4-H youth programs are accessible to youth without regard to race, color, national origin, sex, religion, age or disability.
6. Treat animals humanely and encourage 4-H youth and adults to provide appropriate and ethical animal care.
7. Under no circumstances, allow or consume alcohol or illegal drugs at 4-H events or activities. Understand that the use of or being under the influence of alcohol or illegal drugs while in the presence of 4-H members and/or at 4-H programs or activities is grounds for termination as a volunteer or 4-H Youth Development Educator.
8. The use of tobacco in the presence of 4-H members and/or during 4-H events is **strongly discouraged**, as the use of these products by minors is illegal.
9. Operate machinery, vehicles and other equipment in a safe and responsible manner when working with youth and adults participating in 4-H programs.
10. Accept responsibility to promote, conduct and support 4-H programs in order to develop an effective county, district, state and national 4-H program.



General Rules and Regulations

1. All cattle, goats, sheep, and swine must be nominated in exhibitor's name no later than December 22, 2025. Livestock can be family nominated, but must appear on the nomination report under each potential exhibitor's name.
2. All livestock and showmanship entries must be completed by the show's entry deadline.
3. All exhibitors must be a member of a certified Tulsa County 4-H Club or FFA Chapter prior to December 22, 2025 to show.
4. Youth must be at least 8 years old and in the 3rd grade by September 1, 2025 and must not have graduated high school prior to the show date in order to participate in the Tulsa County Spring Livestock Show.
5. Registration papers on breeding animals must be in the name of the exhibitor and be presented to the superintendent at the time of entry. Cattle registration papers must be in the **sole name** of the exhibitor; sibling or other family names **cannot** be listed as the current owner. **Official, paper copies are required. No pictures on electronic devices or digital copies will be accepted.** Registration paper addresses for owner should be indicative that General Rule #7 is occurring.
6. In order to show in the species' Bred and Owned show, exhibitors must bring an official, paper copy showing that the exhibited animal is registered and that they owned the dam when she was bred. Bred and owned market animals and commercial breeding animals may also show in the Bred and Owned show, but must be registered and meet the same requirements as the B/O breeding animals.
7. Exhibits must have been **owned and fed daily** by Tulsa County 4-H or FFA members by December 22, 2025.
8. **Except for an emergency, exhibitors will be required to show their own animal.** Examples of emergencies are: illness, significant personal or family accidents, etc. In the event of an emergency, permission must be obtained from the species superintendent and Extension personnel to allow another Tulsa County 4-H or Tulsa County FFA member to show for them. In the event the same exhibitor has two or more animals that are required to show at the same time, the owner-exhibitor can have a bona fide Tulsa County 4-H or Tulsa County FFA member to show the second or more animals for them without seeking committee approval.
9. **Female animals (i.e. does, ewes, and gilts) must show in their species' breeding show and will no longer be able to choose to participate in the market show (only male animals).**
10. All exhibitors must show their own animals in the showmanship contest.
11. Animals shown in showmanship contest must be officially entered in the 2026 Tulsa County Spring Livestock Show.
12. Only youth who are 4-H or FFA members and entered in the 2026 Tulsa County Spring Livestock Show may enter showmanship.
13. Health: Should the health of an animal be questioned, visual inspection will be made by the species superintendent or a veterinarian. Any animal not passing will be removed from the barn.
14. All animals must be checked in during the designated check-in times.
15. All animals requiring weigh-in must be weighed-in during designated weigh-in times on official scales provided by the show staff. Failure to weigh-in during designating time will result in the animals' disqualification.
16. All swine must have the original negative pseudo-rabies and Brucellosis test results form with ear tag in place as required by State Department of Agriculture. Premise ID will be required. Either the original paper or original digital results form will be accepted.
17. Cattle must have an 840 RFID tag in their ear. Goats & sheep must have a USDA Scrapie tag in their ear.
18. **Exhibitors are limited to 3 entries per show. (example 3 market entries, and 3 breeding entries)**
19. Show Ring Dress Code (based on Tulsa State Fair and OYE guidelines)
Exhibitors will wear one of the following:
 - 4-H Member:
An official 4-H vest, jacket, sweater or pullover wind jacket.
 - Must be appropriate colors of solid green, solid white, or a mix of green and white. No black or grey will be accepted.

- Must wear a collared shirt under the vest or jacket that is appropriate colors of solid white, solid green, or a mix of green and white.
- Must have official 4-H emblem of at least 2 1/2 inches that is permanently affixed to the front, left side of the vest or jacket. **No club or farm logo will be accepted.**

A buttoned up, collared shirt or polo shirt, short or long sleeve, of the appropriate 4-H colors of Solid green, solid white, or a mix of green and white.

- Must have an official 4-H emblem of at least 2 1/2 inches that is permanently affixed to the front, left side of the shirt. **No club or farm logo will be accepted.**

No third color mix or additional colors will be accepted for any of the previously listed clothing options. (E.g. no black, grey, tan, or any other)

No club or farm logo shall appear on any article of clothing.


FFA Member:

A buttoned up, collared shirt or polo shirt, short or long sleeve, of the appropriate FFA colors of solid white, solid blue, solid yellow, or a mix of blue and yellow.

- No third color mix or additional colors are allowed.
- Must have an official FFA emblem of at least 2 1/2 inches that is permanently affixed to the front and left side of the shirt.

FFA members may wear their FFA jacket for the Tulsa County Junior Livestock Show

20. Stalls and tie will only be provided for animals that are officially entered into the Tulsa County Junior Livestock shows.
21. **The stalling of sheep, goats, or pigs on the trailer will be extremely limited and will be available on a first come, first served basis. Parking in fire lanes, in front of overhead doors and walk-through doors, and blocking other trailers/vehicles in will not be tolerated and may result in the towing of the trailer/vehicle at the owner's expense.**
22. Exhibitors must furnish feed and bedding. No straw is allowed for bedding.
23. Market animals may be purebred or crossbred. If necessary, a committee will determine breed classification.
24. The Tulsa County Junior Livestock Show Committee shall have authority to settle questions which may arise concerning the show. Only the show committee is allowed in the show ring and scale area during weigh-in.
25. **Decision of judge and superintendent is final. There will be no protest.**
26. Failure to abide by the rules of the show shall cause forfeiture of all premiums and awards, and further participation in the Tulsa County Spring Livestock Show.
27. In no case shall the Tulsa County Junior Livestock Show Committee or Tulsa County Public Facilities Authority be responsible for any loss, damage, or disability.
28. **A nomination fee from each group will be required. The nomination fee will be \$50 per head up to 5 head shown, \$400 6-20 head shown, and \$750 for 21 or more head shown. This fee will go towards purchasing awards and paying the Grand and Reserve Grand animal in each species. This money is due on February 6, 2026.**
29. **Breed and Reserve Breed Champions must be present and take part in the Grand and/or Reserve Grand Champion selection for their show. Failure to do so will result in forfeiture of Breed/Reserve Breed winnings and Bonus/Premium Lineup earnings.**
30. The Tulsa County Junior Livestock Show Committee reserves the right to adjust premium amounts due to availability of amount budgeted for the Spring Livestock Show.
31. This is a youth and family event. Responsible conduct is expected and required at all times. Profanity or any other offensive language, abusive conduct or act by an exhibitor, Extension Educator, Agricultural Education Teacher, parent, or 4-H leader will be considered a violation of the Show Ring Code of Ethics and will be subject to the penalties outlined in the Show Ring Code of Ethics. Abusive conduct is defined as, but not limited to: aggressively touching, verbally or physically threatening show officials and/or throwing objects in the presence of show officials.



Weight Requirements for Cattle, Goats, Sheep, and Pigs

Similar to 2025, there will be a weight requirement for all species being shown by weight. Animals weighing less than the minimum weight will still be allowed to show; however, they will be shown in a class prior to the start of the breeding show for their respective species. Similarly, in the swine division, animals above their show's maximum weight will show in an overweight class. All animals within that species will be shown together in that class (either underweight class or overweight class). These classes will still receive class-level payouts but will not be eligible for the bonus/premium lineup within their species. The following weights will be strictly enforced by the species superintendents:

Commercial heifers & prospect steers - 500 pounds

Breeding & market goats - 45 pounds

Commercial ewes & market sheep - 85 pounds

Commercial gilts & market swine - 195 pounds minimum (all shows); 300 pounds maximum (barrows) or 340 pounds maximum (gilts)

Bonus/Premium Lineup (Swine, Goats, Sheep, & Cattle)

Similar to the 2025 show, the swine, goat, sheep, and cattle shows will have an increased entry price of \$20.00 per head to facilitate a bonus/premium lineup (similar to a county premium sale) and a restructuring of earnings to animals placing above the reserve breed champion level. The original \$10.00 entry portion will be paid out in class (similar to past years). The remaining \$10.00 will go into a show-level payout program to help increase monies earned by exhibitors within that individual show.

The judge will be asked to select the top 10% of the animals in their preferred order. Each of the selected exhibitors will receive a portion of the money set aside for that show. The money set aside for each show will consist of \$10.00 from each entry fee, nomination money from each FFA chapter/4-H club, and donations from area businesses/organizations. Allocation amounts will be determined following the deduction of expenses for the Spring Livestock Show (i.e. judges, awards, etc).

The following payout schedule will be used. Exact amount received by each exhibitor will be based on number of head entered in their specific show and the payout schedule below:

Grand Champions - 20%

Reserve Grand Champions - 15%

Breed Champions - equally divided share of 30%

Reserve Breed Champions - equally divided share of 15%

Animals selected for top 10% lineup within their individual show - equal share of 20%

Notes:

Grands, Reserve Grands, Breed Champions, and Reserve Breed champions will be eligible for the top 10% lineup money.

Each exhibitor may receive money once within the portion set aside for the top 10% lineup (i.e. only one breeding gilt per exhibitor can be selected for the breeding gilt top 10% lineup)

Tulsa County Junior Livestock Show Committee has the right to adjust or amend any portion of this payout schedule at any point.

All animals must be checked-in (registration papers checked, official weigh-in completed, etc.) by the designated time. Failure to do so during the designated time will result in the animals' disqualification.

All registered females must have a legible tattoo matching registration paper to be eligible to show. Official, paper copies are required. No pictures or digital copies will be accepted. This will be enforced. If not in compliance, females will not be shown or will be shown as a commercial female. **All cattle (including registered heifers) must have an 840 RFID tag in their ear to compete.**

All commercial heifers and steers must weigh a minimum of 500 pounds. Beef cattle in these divisions not meeting the minimum weight requirement will show together in an under-weight class prior to the start of the registered heifers show. Underweight cattle will receive class-level payouts but will not be eligible for the bonus/premium lineup.

Heifer Rules

1. Present registration papers at time of entry.
2. Official, paper copies of registration papers are required. No pictures or digital copies will be accepted. Cattle registration papers must be in the **sole name** of the exhibitor; sibling or other family names **cannot** be listed as the current owner.
3. Tattoos must be in the ear of the registered heifer and may be checked by Beef superintendent or his/her representative at check-in.
4. Registered heifers must be registered in owners' sole name by January 20, 2026. All heifers need to be owned, fed and cared for daily by the exhibitor by December 22, 2025.
5. No fitting will be allowed at the Tulsa County Spring Livestock Show. This includes adhesives and paint.
6. Heifers must be born between January 1, 2024 and August 31, 2025 to be eligible to show. Calves born after January 1, 2026, whose dam is a Registered Female being shown at the show, can be shown alongside their dam, **with Superintendent approval**. Commercial heifer pairs will not be shown.
7. Classes will be broken by superintendent.
8. Breeds with an individual breed show at the Oklahoma Youth Expo will be allowed to show within their specific breed. Purebred and percentage registered animals (i.e. Shorthorn and Shorthorn Plus) will be shown together. All other breeds not individually recognized by OYE will be allowed to show in either the AOB or Commercial division. Two (2) animals of a breed and two or more owners from two or more households are required to constitute a breed; **otherwise, they will be shown as AOB (date of birth) or Commercial (weight)**.
9. AOB (if needed) will be the first breed to show in the registered heifer show.
10. Commercial heifer classes will be broken by weight. **Minimum weight of 500 pounds**.
11. Heifers can be shown as Registered or Commercial Heifers but **not both**.
12. There is no weight limit and no papers required for commercial heifers.
13. All heifers must be free of contagious disease. Heifers determined to be infected with a contagious disease, will not be allowed to show and must be removed from the barn.
14. Registration papers required for Bred and Owned class. Bred and Owned class will occur after the steer champion drive. If no market animals are entered, it will occur after the heifer champion drive.
15. Fitting will not be allowed. This includes adhesives and paint.

Bred and Owned

Bred and owned heifers must be registered in exhibitors name and papers must show exhibitor owned the dam when she was bred. Bred and owned steers and commercial heifers may show in the Bred and Owned Show, but must be registered and meet the same requirements as the B/O heifers.

Steer Rules


1. All steers must be owned and fed daily by exhibitor by December 22, 2025.
2. Must have a full set of baby teeth with no signs of permanent teeth.
3. Beef Division Superintendent will weigh and divide steers into classes.
4. **Steers will be divided into two classes - Prospect and Progress. Prospect Steers will weigh 500-999 pounds, while progress steers will weigh 1,000 pounds or more.**
5. All steers must be free of contagious disease. Steers determined to be infected with a contagious disease, will not be allowed to show and must be removed from the barn.
6. Fitting will not be allowed. This includes adhesives and paint.

All animals must be checked-in (official weigh-in completed, etc.) by the designated time. Failure to do so during the designated time will result in the animals' disqualification.

All goats must have an USDA Scrapie tag in their ear to compete.

All breeding meat goats and market goats must weigh a minimum of 45 pounds. Meat goats not meeting the minimum weight requirement will show together in an underweight class prior to the start of the breeding meat goat show. Underweight goats will receive class-level payouts, but will not be eligible for the bonus/premium lineup.

1. Must have been owned and fed daily by exhibitor by December 22, 2025.
2. **All does must show in the Breeding Doe division. Does cannot show in the Market Wether Goat show.**
3. All breeding goats must be free of contagious diseases, or they will not be allowed to show and must be removed from grounds.
4. Must have milk teeth.
5. All breeding goats will be shown by weight.
6. No bucks are allowed to show.
7. No maximum weight limits (see minimum weight rule above).
8. Class size will be determined by the Meat Goat Division Superintendent.
9. Breeding meat goats cannot be braced. No exceptions. The judge and species superintendent have the authority to ask the exhibitor to step back from the animal.
10. Registration papers required for Bred and Owned class. Bred and Owned class will occur after the Market Wether Goat champion drive. If no market animals are entered, it will occur after the Breeding Doe champion drive.
11. Fitting will not be allowed. This includes adhesives and paints.

2. All market wethers must be free of contagious diseases, or they will not be allowed to show and must be removed from grounds.
3. Must have milk teeth.
4. All market wethers will be shown by weight.
5. No bucks are allowed to show.
6. No maximum weight limits (see minimum weight rule above).
7. Class size will be determined by the Meat Goat Division Superintendent.
8. Bracing is allowed in the Market Wether Goat show only.
9. Fitting will not be allowed. This includes adhesives and paints.

Bred and Owned

Bred and owned does must be registered in exhibitors name and papers must show exhibitor owned the dam when she was bred. Bred and owned wethers may show in the Bred and Owned Show but must be registered and meet the same requirements as the B/O does.


1. The Meat Goat Division Superintendent will determine class breaks and class size.

All sheep must have an USDA Scrapie tag in their ear to compete.

All commercial ewes and market lambs must weigh a minimum of 85 pounds. Lambs not meeting the minimum weight requirement will show together in an underweight class prior to the start of the breeding ewe show. Underweight lambs will receive class-level payouts but will not be eligible for the bonus/premium lineup.

Breeding Ewe Rules

1. Ewes must be owned and fed daily by December 22, 2025.
2. **All ewes must show in the Breeding Ewe division. Ewes cannot show in the Market Wether Lamb show.**
3. Registered ewes will show by age and will be verified (via official, paper registration papers) during check-in. Commercial ewes will show by weight (see weight requirement above).
4. All lambs must be free of contagious disease. Lambs determined to be infected with a contagious disease, will not be allowed to show and must be removed from the barn.
5. Two (2) animals of a breed and two or more owners from two or more households are required to constitute a breed; **otherwise, they will be shown as an AOB.**
6. Registration papers required for Bred and Owned class. Bred and Owned class will occur after the Market Wether Lamb champion drive. If no market animals are entered, it will occur after the Breeding Ewe champion drive.
7. AOB (if needed) will be the first breed to show in the registered ewe show.
8. **All breeding ewes must be slick shorn to no longer than 1/4" and uniform over the entire body before entering the show ring. No wool is allowed above the knees or hocks. A wool cap is acceptable in the Purebred Breeding Ewe Show only.**



1. All swine must have the original negative pseudo-rabies and Brucellosis test results form with ear tag in place as required by State Department of Agriculture. Premise ID will be required. Either the original paper or original digital results form will be accepted.
2. All swine must be fed, owned and cared for daily by exhibitor by December 22, 2025.
3. All gilts must show in the Breeding Gilt division. Gilts cannot show in the Market Barrow show.
4. Two (2) animals of a breed and two or more owners from two or more households are required to constitute a breed; otherwise, they will be shown as an AOB.
5. Gilts shown in purebred classes must be registered in the name of the exhibitor. **Maximum weight for commercial gilts is 340 pounds. See weight rule outlined above.**
6. All gilts must be free of contagious disease. Gilts determined to be infected with a contagious disease, will not be allowed to show and must be removed from the barn.
7. Purebred gilts will be shown by age. Purebred Gilts must be farrowed between July 1, 2025 and October 31, 2025. **No papered barrows; all barrows must show in Market Barrow show.**
8. Registration papers required for Bred and Owned class. Bred and Owned class will occur after the Market Barrow champion drive. If no market animals are entered, it will occur after the Breeding Gilt champion drive.
9. The Swine Division Superintendent will be responsible for determining class size, swine weigh-in and classification.
10. AOB (if needed) will be the first breed to show in the breeding gilt show.
