

**From the West:** From the intersection of Highway 51 and Country Club Road, go 1 mile north on Country Club Road, turn east on McElroy, go 1 mile, turn and go north 1/8<sup>th</sup> mile north on Sangre.

From the East: From the intersection of McElroy and Sangre, go 1/8<sup>th</sup> mile north on Sangre.
