Preface

The "Abstract of the General Fund for Counties in Oklahoma, 2000 Edition," was published in 2000 and contained county financial information for the 1998 - 1999 fiscal year. Since that time, a significant effort has been made to remake the publication to provide a more complete picture of county government finances. The result was the "Abstract of County Government General, Highway, and Special Revenue Funds in Oklahoma, Fiscal Year 2002 – 2003." This current publication is an update of this new publication format. Following is a brief explanation of each of the six tables:

- Table 1. Total revenue by county to the General Fund, the Highway Fund(s), and the Special Revenue(Cash) Funds. This table reflects fiscal year receipts and does not reflect any cash fundbalance carried forward from the prior year.
- Table 2. Total expenditures by county from the General, Highway, and Special Revenue Funds for the
fiscal year. Note that total expenditure is defined as total warrants issued plus total reserves
as of the last day of the fiscal year.
- Table 3. Fund balances by county at the end of the fiscal year that are unexpended and unencumbered monies and are carried forward into the next fiscal year.
- Table 4. Selected revenue streams feature the primary sources of revenue to General, Highway, and some Special Revenue Funds. All Ad Valorem revenue goes into the General Fund. Counties Sales Tax revenue may be appropriated to the General Fund or Special Revenue Funds or both. Fuel Taxes comprise the majority of revenue to the county Highway Fund. Motor Vehicle Fees (taxes) are a source of revenue for both the General and the Highway Funds; the larger portion being allocated (by State statute) to the Highway Fund.
- Table 5. The assessed valuations of each county in 2016 form the basis for the ad valorem tax collectedin fiscal year 2016-2017, designated FY 2017. By statute taxable property is classified aseither Real Property (land and buildings), Personal Property (such as furniture, fixtures,inventory, and household goods), and Public Service Property (centrally assessed utility andtransportation company properties). All numbers shown here are net of tax increment finance(TIF) district increments.
- Table 6. County by county summary of revenues and expenditures by fund is provided, including additional detail for the General Fund.

Note that for fiscal year 2017, some counties had greater expenditures than revenues. This is possible because each fund usually starts the year with a significant fund balance carried forward from the previous year.
